#### **DESCRIPTION**

Childers® CHIL-GLAS® #10 reinforcing mesh is a high-strength, open-weave, pre-sized, resin-treated, fiberglass cloth. It is used in conjunction with various types of coatings to provide reinforcement of and thickness control for the coating. It also provides a method to bridge gaps, joints and crevices in the insulation. It will not burn, and it meets or exceeds all government or private safety codes.

CHIL-GLAS® #10 glass fiber reinforcing mesh incorporates a thread count of 10 strands by 10 strands per square inch into its construction. The standard roll size is 39" x 150' x 0.008" in thickness. A roll weighs 1.9 ounces per square yard and is packaged 4 rolls per carton.

### **APPLICATION**

Embed the CHIL-GLAS® #10 glass fiber reinforcing mesh into a tack coat of the protective coating, and then apply a finish coat immediately. Be sure to overlap all seams of the CHIL-GLAS® #10 glass fiber reinforcing mesh at least two inches. Follow the application instructions for the mastic or coating selected.
